The Division of Gaming Enforcement (DGE) is a law enforcement agency and the investigative arm of the casino regulatory system responsible for enforcing the Casino Control Act.

You have to be aware, though, that there are fraudsters who will leave a link to a fake website, which can put you in trouble.

To obtain a license from the UKGC, companies need to provide detailed information, such as a business plan, proof of financial stability and funding, proof of no criminal conviction, and many more.

Depending on the jurisdiction where your business is incorporated, there are a range of legal ramifications for organizing unlicensed gambling activities, including fines and prison time.

· Check for Logo: Go to the bottom of the home page of that casino's website and look if there is any gambling commission logo.

While regulators in many countries require operators to hold a local license, there are a number of jurisdictions around the world that issue licenses which enjoy international recognition.

Most importantly, the sub-license allows the holder to organize all kinds of casino gaming and sports betting, whereas some other authorities require an additional license for each kind of activity the licensee wants to offer.

Apart from the jurisdictions above, online casino owners can also obtain a license from the UK, Alderney, Macao, Belgium, Denmark, Isle of Man and some other countries.

Namely, from October 1, 2021, the DCMS outlined an increase in annual fees for remote operating licences by 55%.

The Gambling Supervision Commission started to regulate online gambling in 2001, and currently issues several types of license based on the class of company (B2C licensees can organize all types of gambling activity).

Licenses are required of casino owners and operators, casino employees, and companies that do business with casinos in order to ensure that those involved with this industry meet the statutory requirements of good character, honesty and integrity and to keep the New Jersey casino industry free from organized crime.

Unlike Curacao, Malta offers four classes of license, each of which allows the holder to organize a different kind of activity.

Remote casino license holders need to pay a gaming duty between 15% and 50% of the gross gaming yield depending on how big the GGR is.

Instead of charging annual license renewal fees — and all the fees that come along with application processes — the Licensing Authority charges a single lump sum; remote operator licenses cost £100,000 for a five-year license.

If there is no logo, the casino won't have a license; you should immediately leave the site and find a licensed casino.

The Caribbean island of Curacao is one of iGaming's oldest regulators, having started to issue licenses in 1996. The island's modern infrastructure and business-friendly tax rates make it a popular location for international industries.

· Gibraltar License: Gibraltar Licensing Authority has been issuing licenses for casinos for several years now, and their license is trusted widely by players.

If the project satisfies authorities and there isn't a substantial number of player complaints, the next license, valid for five5 years, is issued.

Licenses are valid for 10 years.

New operators apply for a sub-license from a master license holder (the four master license holders have been fixed since 1996).

Even after a new operator has settled on a jurisdiction, mountains of paperwork and an often bureaucratic application process can leave potential operators frustrated and confused — not to mention disappointed, if a minor-slip on one of their many forms snowballs into total rejection.

The Curacao Gaming License has become highly sought-after, especially for new operators.

The Mohawk Territory of Kahnawake in Quebec is home to the Kahnawake Gaming Commission, which has been issuing licenses since 1999. Operators apply for a Client Provider Authorization, which enables them to organize all kinds of casino gaming and sports betting — except for live casino games, for which the KGC offers a Live Dealer Studio Authorization.
